

SUMMARY ANNUAL REPORT FOR WESTERN PENNSYLVANIA TEAMSTERS AND EMPLOYERS WELFARE FUND

This is a summary of the annual report of the Western Pennsylvania Teamsters and Employers Welfare Fund (Employer Identification Number 25-1000614, Plan Number 501), for the plan year 01/01/2016 through 12/31/2016. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has insurance contracts with Vision Benefits of America and Metropolitan Life Insurance Company to pay certain vision, life insurance, and accidental death and disability claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2016 were \$854,762.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2016, the premiums paid under such "experience-rated" contracts were \$463,721 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$437,068.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$70,922,137 as of the end of plan year, compared to \$66,460,714 as of the beginning of the plan year. During the plan year the plan experienced an increase in its net assets of \$4,461,423. This change includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$59,554,490 including employer contributions of \$53,897,377, employee contributions of \$292,456, realized gains of \$705,014 from the sale of assets, and earnings from investments of \$4,507,221. Plan expenses were \$55,093,067. These expenses included \$4,031,468 in administrative expenses, and \$51,061,599 in benefits paid to participants and beneficiaries.

2. Financial information and information on payments to service providers.
3. Assets held for investment.
4. Transactions in excess of 5 percent of the plan assets.
5. Insurance information, including sales commissions paid by insurance carriers.
6. Information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
